**Section 4: First-Aid Measures**
**Description of first aid measures:**

**In case of inhalation:** If breathing difficulties develop, move victim away from exposure and into fresh air. If not breathing, give artificial respiration.

**In case of skin contact:** May cause skin irritation. Wash off with soap and plenty of water.

**Advice on safe handling:** User Exposure: Avoid inhalation. Avoid contact with eyes, skin, and clothing. Avoid prolonged or repeated exposure.
