### Section 4: First-Aid Measures

**Description of first aid measures:**

**In case of inhalation:** Remove from exposure to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Seek medical attention if cough or other symptoms appear.

**In case of skin contact:** Flush skin immediately with plenty of soap and water for at least 15 minutes while removing contaminated clothing and shoes. Seek medical attention if irritation develops or persists.

**In case of eye contact:** Flush eyes immediately with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Seek medical attention immediately.

**In case of ingestion:** If victim is conscious and alert, give 2-4 cups of milk or water. Seek medical attention immediately.

**Most important symptoms and effects, both acute and delayed:**

**Inhalation:** Inhalation of fumes may cause metal fume fever, which is characterized by flu-like symptoms with metallic taste, fever, chills, cough, weakness, chest pain, muscle pain and increased white blood cell count. May cause lung damage.

**Eyes:** Exposure to particulate or solution may cause conjunctivitis, ulceration, and corneal abnormalities.

**Skin contact:** May cause skin irritation.

**Ingestion:** May cause gastrointestinal irritation with nausea, vomiting and diarrhoea. Acute toxicity may include weakness, shock, cyanosis and acidosis. Delayed symptoms may include liver damage.

**Indication of any immediate medical attention and special treatment needed:** Treat symptomatically. Show this safety data sheet to a physician or emergency room.

### Section 5: Fire-Fighting Measures

**Extinguisher media:**

**Suitable extinguisher media:** Use powdered graphite, powdered salt, or powdered limestone.

**Unsuitable extinguishing media:** DO NOT use water, carbon dioxide or dry chemical.

**Special hazards arising from the mixture:** Moderate explosion hazard in the form of a dust when exposed to heat or flame.

**Advice for fire-fighters:** Use NIOSH-approved self-contained breathing apparatus and full protective equipment. Fumes from fire are hazardous. Isolate runoff to prevent environmental pollution.

**Further information:** Moderate fire hazard in the form of a dust when exposed to heat or flame. Can react with water to liberate flammable hydrogen gas. Minimum ignition temperature, iron dust cloud: 430 °C (805 °F). Ultrafine iron powder (ca. 5 microns) is pyrophoric and can ignite spontaneously in air.

**Personal precautions:** Use proper personal protective equipment as indicated in Section 8.

**Environmental precautions:** Prevent product from entering drains. Prevent further leakage or spillage if safe to do so. Local authorities should be advised if significant spillages cannot be contained.

**Methods for cleaning up:** Sweep up or absorb material, then place into a suitable clean, dry, closed container for disposal. Avoid generating dusty conditions. Remove all sources of ignition.
