## **Section 4: First-Aid Measures**

### **Description of first aid measures:**

**In case of inhalation:** Remove from exposure to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention.

## Most important symptoms and effects, both acute and delayed:

**Inhalation:** Causes respiratory tract irritation. Can produce delayed pulmonary edema. The toxicological properties of this substance have not been fully investigated.

Eyes: Causes eye irritation. May cause chemical conjunctivitis.

Skin contact: Causes skin irritation.

**Ingestion:** May cause gastrointestinal irritation with nausea, vomiting and diarrhoea. The toxicological properties of this substance have not been fully investigated.
