Section 4: First-Aid Measures

Description of first aid measures:

Section 5: Fire-Fighting Measures

Extinguisher media:

Suitable extinguisher media: Powder Fires: Class D extinguisher or special powder for metal fires. Do not use water. Solid Material Fires: Non-flammable. Use extinguishing media suitable for surrounding material and type of fire.

Section 6: Accidental Release Measures

Personal precautions, protective equipment and emergency procedures:
