Section 4: First-Aid Measures

Description of first aid measures:

In case of inhalation: If inhaled, remove to fresh air. If not breathing give artificial respiration. If breathing is difficult, give oxygen.

Personal precautions: Evacuate area. Shut off all sources of ignition. Use non-sparking tools. Wear self-contained breathing apparatus, rubber boots, and heavy rubber gloves. Avoid breathing vapours, mist or gas.
